

# Highlands Campus Day Camp Consent Form

This form is required to complete the registration for Highlands Day Camp.

By registering my student(s) for Day Camp, I consent for my student(s) to participate in Fincastle Baptist Church's Day Camp to be held on Wednesday's beginning September 9<sup>th</sup>. I do authorize any staff member of the church to make any necessary emergency medical decisions for my student(s). This includes first aid, hospitalization, medical treatment, and transportation for my student(s) if needed.

I understand I will be contacted as soon as possible about serious injuries and/or treatment administered to my student(s).

By signing this agreement, I acknowledge the contagious nature of COVID -19 and voluntarily assume the risk that I, or my child, may be exposed to or infected by COVID-19 by participating in Fincastle Baptist Church, Inc.'s Day Camp and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to personal injury, disability and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, or my child, may experience or incur in connection with participation in Fincastle Baptist Church, Inc.'s Day Camp ("Claims"). On my behalf, and on behalf of all assignees, heirs, executors, administrators, and personal representatives, I hereby release, covenant not to sue, discharge, and hold harmless Fincastle Baptist Church, Inc., and all respective employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the released entities, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during or after participation in any program.

I also give Fincastle Baptist Church permission to use photos that are taken of my child for church promotional use.

I have read the safety information document outlining the most current procedures as per our governor's orders which can be found below.

I further state that I have carefully read and understand the foregoing release, know the contents hereof are true, and sign this release as a legally binding agreement.

# Safety Information for Highlands Campus Day Camp

## DATES & TIMES:

Wednesday's beginning September 9th

Drop-off is between 7:45 – 8:15 AM and pick-up is between 3:15 - 3:45 PM

In consultation with health professionals and based on Governor Northam's latest Executive Order the following policies will be adhered to:

- Based on the size of our facility we are able to accommodate 30 students at the Highlands Campus.
- Social distancing will be practiced.
- ALL volunteers and staff will have their temperatures taken upon arrival and will wear a mask.
- Anyone with COVID-19 symptoms or that has been exposed to COVID-19 will NOT be permitted in the building.
- Enhanced cleaning procedures will be implemented.
- As much as possible, the program will be a touch-free environment with limited handouts, sharing of supplies, etc.

## REGISTRATION PROCEDURES:

- Registration is available only online at [fincastlebaptist.org/camp](https://fincastlebaptist.org/camp)
- Registration is limited to 30 students at the Highlands Campus.
- You will receive a confirmation email upon completion of registration.

## DROP-OFF PROCEDURES:

- Parents and other family members are prohibited from entering the building.
- Students will be dropped off on Oak Street in front of the building and screened immediately after they get out of the car.
- Screenings will include:
  - 1) Checking the student's temperature with a forehead thermometer (any temperature 100.4 or higher will not be allowed to stay).
  - 2) Verbal questioning to determine the student's exposure to COVID-19 or people exhibiting COVID-19 symptoms.
- After the screening is complete, a staff member will take the student inside to a socially distanced area.
- Parents may then leave the screening area to accommodate screening of other students.

## PICK UP PROCEDURES:

- Upon dropping off your student(s), parents will receive a sign with their child's name. This sign is to be placed in the car window upon arrival for pick-up. During the online registration process, you will be asked for the names of those authorized to pick up your student. If the person picking up your student does not have the sign, we will check their photo id to be sure they have been authorized by you to pick them up.
- All students will be picked up on Oak Street in front of the building.
- Parents are NOT allowed in the building so please do not exit your vehicle. A staff member will bring your student to your car.
- Once your student is safely in the car, you may exit the property.
